AN ORDER REORGANIZING THE MUNICIPAL INTER-AGENCY COMMITTEE (MIAC) FOR KALAHI CIDSS-NCDDP CBRC – AF IMPLEMENTATION, THIS MUNICIPALITY

WHEREAS, the Municipality of Tunga is one of the recipients and beneficiary among twenty-six (26) municipalities for Kapit Bisig Laban sa Kahirapan Comprehensive and Integrated Delivery of Social Services National Community Driven Development Program (KALAHI CIDSS-NCDDP) Extension Implementation;

WHEREAS, the Municipal Inter-Agency Committee need to be reorganized appropriate for this administration;

WHEREAS, the LGU of Tunga supports and recognizes the KALAHI CIDSS-NCDDP as a significant mechanism for inclusive growth and poverty reduction for the constituents and also provide counterpart funding which is stipulated in the Local Counterpart Contribution (LCC) Plan;
