EXECUTIVE ORDER RE-ACTIVATING THE MUNICIPAL COORDINATING TEAM (MCT) FOR THE KAPIT BISIG LABAN SA KAHIRAPAN COMPREHENSIVE & INTEGRATED DELIVERY OF SOCIAL SERVICES (KALAHI-CIDSS) KAPANGYARIHAN AT KAUNLARAN SA BARANGAY (KKB) CASH FOR WORK IMPLEMENTATION.

WHEREAS, it is a thrust of the government to eliminate poverty and empower citizens through various activities and trainings to capacitate them to identify and solve community concerns that affect local poverty situation;

WHEREAS, to ensure efficient implementation of the cash for work program the Municipal Coordinating Team (MCT) shall be responsible for the development strategy as well as the formulation of plans and programs with the collaborative efforts of the community and the Local Government Unit in order to develop social accountability, transparency and good governance;

WHEREAS, Book III, Title 2, Chapter 3, Article 1, Section 444 (iii) of Republic Act 7160 or otherwise known as the Local Government Code of 1991, clearly states that the Municipal Mayor may issue such Executive Orders as are necessary for the proper enforcement and execution of laws and ordinances;

WHEREAS, reconstituting of the Municipal Coordinating Team (MCT) the following is hereby reconstituted composition with their functions:

NOW, THEREFORE, I CATALINA F. AGDA, Municipal Mayor of Tunga, Leyte by virtue powers vested in me by law, do hereby order to reconstitute, create a Municipal Coordinating Team (MCT) for the implementation of Cash for Work Program under KALAHI-CIDSS Kapangyarihan at Kaunlaran sa Barangay (KKB) in the Municipality of Tunga, Leyte.

SECTION 2. **Duties and Function-** The Municipal Coordinating Team shall perform the following functions:

1. Frontline over-all implementer of the project in the Municipality. This shall be headed by the KC Focal Person under the administrative supervision of the Local Chief Executive (LCE).
2. Coordinate, monitor and evaluate the implementation of development programs and projects by the program and the MLGU; and
3. Perform such other function as may be provided by law or competent authority.

SECTION 3. **Repealing Clause-** Any provisions specifically provided for herein that is contrary to existing laws and the Constitution are hereby repealed without prejudicing other provisions stated herein.

SECTION 4. **Effectivity-** This order shall take effect immediately and shall remain effective until further amended or revoked.
