



Executive Order No. 20

AN ORDER DECLARING PORK HOLIDAY FROM 13 JUNE TO 26 JUNE 2021 TO MITIGATE THE EFFECTS OF AFRICAN SWINE FEVER INFECTION IN THE MUNICIPALITY OF TUNGA

WHEREAS, Section 16 of R.A.7160 (Local Government Code) provides that "*(E) very local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants*";

WHEREAS, Section 444, paragraph b (2) (iii), provides that the Local Chief Executive shall have the authority to, "*Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances*";

WHEREAS, based on the communication letter from Department of Agriculture Regional Office 8 dated 07 June 2021 it was confirmed that ASF Virus was already detected in Barangay Banawang this Municipality;

WHEREAS, there is a need to STRICTLY IMPOSE the control measures to effectively address the virus;

NOW, THEREFORE, I, CATALINA F. AGDA, Mayor of the Municipality of Tunga, Leyte by virtue of the powers and authority vested in me by law, do hereby order and direct:

SECTION 1. PORK HOLIDAY. Slaughtering and selling of live pigs and pork shall be prohibited from 13 June to 26 June 2021 except canned pork products from reliable manufacturers.

SECTION 2. ASF CHECKPOINTS AND BARANGAY MONITORING. CHECKPOINTS and MONITORING shall be intensified from all entry and exit points in the Municipality of Tunga. It shall be manned by MAO, local PNP and Barangay Officials.

SECTION 3. MEETING AND ASSESSMENT. Meetings and assessment shall be held as needed by the ASF Task Force.


SECTION 4. VIOLATION. All who would violate this EO shall be dealt in accordance to existing laws relative the ASF Guidelines;


SECTION 9. EFFECTIVITY. This order shall take effect on 13th June 2021.






